Communications McCreary Exceptional Support Group

At this time, Chairman Kidd introduced Hope Daugherty, spokesperson for McCreary Exceptional Support Group. Mrs. Daugherty explained the groups' mission and what information and resources are offered to parents, students, the community and the school system. Mrs. Daugherty shared with the Board that the Group was founded 2 1/2 years ago. Mrs. Daugherty explained that it was a place of encouragement, acceptance and resources. It is a place they can find help amidst frustration and connect among others sharing similar life challenges and joys. She shared that it is their goal to empower individuals living with Autism to achieve their highest level of independence within their home, school and community. They believe that an individual living with Autism has the right to a loving, secure and nurturing environment. They also believe that individuals with Autism needs understanding, acceptance and respect. Mrs. Daugherty introduced Michelle Marnhout. Ms. Marnhout shared with the Board the statistics for our county. There are 46 diagnosed in the County and that averages 7 per school. She also shared that there are 1 in 68 diagnosed with Autism. She also said that it can take anywhere from 9 to 15 months before someone can be seen and diagnosed. Mrs. Daugherty shared a list of Support Group Resources the school district can use that are free to educate our staff. She did share with the Board that Larry Taylor (former Assistant Superintendent of McCreary County School District) works with KATC (Kentucky Autism Training Center. He has told her that he would be happy to come to our district and offer training for our staff.
