A. McCreary County Middle School Annual Report

At this time, Mr. Todd Waters, Principal, shared with the Board the Proficient/Distinguished (P/D) Percentages for Reading, Math, Social Studies, and Writing On-Demand. Also, he shared the different Demographic Groups Performance Levels. He shared The Gap Data, as well as how MCMS ranked against surrounding Districts.

B. Whitley City Elementary School Annual Report

At this time, Mr. Foster Jones, Principal, presented Whitley City Elementary School's annual report to the Board. Mr. Jones shared with the Board the Proficient/Distinguished (P/D) Percentages for Reading, Math, Social Studies, Language Mechanics, and Writing On-Demand. He shared the different demographic group performance levels. He went over the GAP data, as well as how WCES ranked against surrounding Districts.

C. Pine Knot Elementary School Annual Report

At this time, Ms. Rebecca Blakely, Principal, presented Pine Knot Elementary Percentages for Reading, Math, Social Studies, Language Mechanics, and Writing On-Demand. She shared the different demographic group performance levels. She went over the GAP data, as well as how PKES ranked against surrounding Districts. Ms. Blakely reviewed achievement data from last year's PKPS and PKIS before they combined into one school.

D. McCreary Central High School Annual Report

At this time, Ms. Sharon Privett, Principal, presented McCreary Central High School's annual report to the Board. Ms. Privett reviewed the Proficient/Distinguished (P/D) Percentages for Algebra II, Biology, US History, and Writing On-Demand. She shared the different demographic group performance

levels. She went over the GAP data, as well as ACT scores, college and career readiness, and graduation rate. MCHS was recently recognized for most improved achievement for KPREP.

At this time Assistant Superintendent Aaron Anderson reviewed the District's overall rating and the new rating system the district will have next year. He went over the District scores, demographic groups by school level, novice/apprentice/proficient/distinguished (NAPD), GAP groups by school level, novice reduction by school level, categorical growth by school level, college and career readiness, ACT, and graduation rates. He shared a developmental video pertaining to preschool growth involving skipping and enhancing reading skills.
