The McCreary County School District is dedicated to serving the students in our community in all aspects of their education. To meet a growing need for sub bus drivers the school district is removing some of the initial costs associated with enrolling in the training program and therefore providing increased potential that sub drivers will enroll.

- The incentive program applies to potential new sub-bus drivers who will be enrolled in the McCreary County School District Driver Training Program only
- The McCreary County School District will pay for the criminal background check not to exceed \$20.00
- The McCreary County School District will pay for an initial physical not to exceed \$95.00
- The McCreary County School District will pay for fees associated with obtaining the CDL application, permit, and license (bus driver endorsement only) Not to exceed \$60.00

- Upon full-completion of their training program and being available to drive for one (1) school year after they receive their license, the new sub-bus driver will receive a one-time \$100.00 training stipend
- The Sub Bus Driver Incentive Program will be limited to the initial ten (10) applicants that apply. Additional positions to the program will be advertised on an as needed basis upon request of the McCreary County Board of Education. Total cost of Sub Bus Driver Incentive Program is \$2,750.00 to be paid from Transportation Budget.
