1. Superintendent News

SKRECC Check and Facility pictures and Superintendent Award

He also shared with the Board that the district had received a check from South Kentucky RECC for \$20,294.44 and will receive another check in July for the energy savings the district had received. Superintendent Cash shared some of the upgrades the schools had made on their buildings and shared some pictures: MCHS Concession Stand, Auditorium Stage flooring and artwork on gym floor; MCMS Secure Vestibule Entry was completed and artwork on gym floor and PKIS artwork on gym floor and new lockers installed.
