MCHS News- Ms. Sharon Privett - ARC "Power" Initiative Grant - Ms. Privett, Principal at McCreary Central High School, shared with the board the ARC Grant she is working on with four other surrounding counties in Kentucky and four surrounding counties in Tennessee. This "Power" Grant is a federal program that will help communities and regions that have been affected by the job losses in the coal mining, coal power plant operations and coal related supply chain industries due to the changing economics of American's energy production. Ms. Privett shared that the high school is looking at \$35,000 that would be targeted to our CTE classes. She also shared opportunities that we will be able to experience if we get this grant. The application is being processed and she will keep the board updated on the status of the Grant.
